## MAIL BOX POLICY

This Mail Box Policy was approved by the Board of Directors (the "Board") for Memorial Thicket Homeowners Association, Inc. ("MTHA"), on the 28<sup>th</sup> day of December, 2011.

1. Each mail box in Memorial Thicket shall be constructed of brick, stone, masonry or cast aluminum, but in no event shall be made of wood.
2. The design and size of all mail boxes shall be compatible with existing mail boxes in Memorial Thicket as determined by the Architectural Control Committee.
3. Any replacement of a mail box requires the prior approval of the Architectural Control Committee to ensure conformity with this policy.

**This Mail Box Policy is applicable to the following described property:** The recording data for Memorial Thicket is 64.0722 acres of land out of MEMORIAL THICKET, SECTION ONE, as per the map or plat of MEMORIAL THICKET, SECTION ONE, recorded on Volume 285, Page 107, of the Harris County Map Records, and 3.1455 acres of land located in the Joel Wheaton Survey, Abstract No. 80, known as MEMORIAL THICKET, SECTION THREE, according to the plat filed under clerk's file number N396306 and recorded under film code number 350088 of the Harris County Map Records, and any additional tracts or parcels of land as may thereafter have been brought within the jurisdiction of the subdivision.



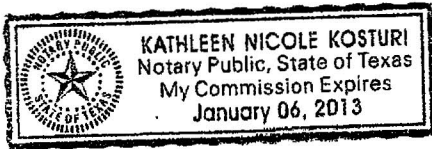
