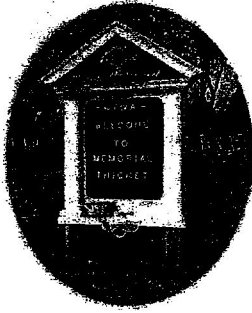

**COMPOSTING DEVICES POLICY**

This Composting Devices Policy was approved by the Board of Directors (the "Board") for Memorial Thicket Homeowners Association, Inc. ("MTHA"), on the 28<sup>th</sup> day of December, 2011.


1. Unless otherwise approved by the Architectural Control Committee, no composting device shall be permitted on any lot except in an area located within the fenced yard or patio of that lot such that the composting device is not readily visible from the street, any adjoining lot or any common area.
2. Any noxious or otherwise offensive odors that substantially interfere with the use or enjoyment of land by causing unreasonable discomfort or annoyance to persons of ordinary sensibilities shall be remedied by the Member owning the composting device within a reasonable time, but in any event not to exceed two weeks.

**This Composting Devices Policy is applicable to the following described property:** The recording data for Memorial Thicket is 64.0722 acres of land out of MEMORIAL THICKET, SECTION ONE, as per the map or plat of MEMORIAL THICKET, SECTION ONE, recorded on Volume 285, Page 107, of the Harris County Map Records, and 3.1455 acres of land located in the Joel Wheaton Survey, Abstract No. 80, known as MEMORIAL THICKET, SECTION THREE, according to the plat filed under clerk's file number N396306 and recorded under film code number 350088 of the Harris County Map Records, and any additional tracts or parcels of land as may thereafter have been brought within the jurisdiction of the subdivision.

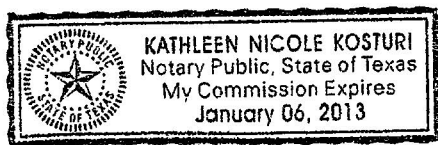
